AGREEMENT REFERENCE

1. Liability. The renter is responsible for the bicycle and any damage, theft or loss during the rental period, subject to applicable law.

2. Condition. The renter confirms that the bicycle is in good condition at pickup, except for any recorded defects, and agrees to return it in the same condition, allowing for normal wear and tear.

3. Traffic laws. The renter agrees to obey all local traffic laws and ride safely.

4. Age limit. Renters must be aged 18 or over, or supervised by an adult. Where the renter is under 18, the supervising adult must be identified and sign below.

5. Use. Bicycles are for recreational use only and must not be used for racing, stunts or off-road riding unless expressly agreed by the Provider.

6. Late returns. Return at the time shown in your booking. Contact us immediately if delayed. Extra time is charged at the next applicable rental band; delays beyond opening hours may incur reasonable recovery costs.

7. Deposit. The deposit may be retained, or charges applied, for damage, late return or missing accessories, subject to applicable law.

8. Helmet use. Helmet use is encouraged and may be required on certain guided tours. Any helmet requirements under applicable traffic laws must be followed.
